### **TARIFFS FOR SOUTHERN IRELAND:**

IPKSA membership is €75 for an Individual and €150 for a family.

We provide insurance cover with membership.

Family membership covers 2 adults and as many children as required who:-

- 1) Live at the Same Address
- 2) Children must be under 18 years of age.

As a member you will receive a Membership Card, your own individual IPKSA 'IR No.', updates on races and event information, access to coaching for pilots license, attendance and voting rights at IPKSA AGM and eligibility to the Committee. Membership is for 12 months. IPKSA Logos will be issued with membership.

A Pilots license indicates the competency of the kite flyer and may also be required for members who wish to compete in competitions. These licenses are recognised internationally by other kiting associations and will allow competitors to enter the relevant events that match their ability.

There are five types:

<u>'None'</u>	-	New member.
<u>'Club'</u>	-	Know the basics and can kite safely.
<u>'National'</u>	-	Able to race at National level.
<u>'International'</u>	-	Able to race at International level.
<u>'Instructor'</u>	-	Capable of teaching the above levels.
